The past year, CBRE increased its number of buildings under management in Chicago to 332, for a total square-footage of 69,298,217, square feet, a significant gain from 40,771,587 square feet the year prior. Colliers International Chicago added 8,662,829 SF of new properties to its property management footprint in the Chicago area over the last year. This growth was offset by 8,249,373 SF of property sales and transfers, resulting in a final managed portfolio size of 45,513,169 SF. We added 10 new clients and expanded portfolios with nine existing clients. Notable new assignments in the last 12 months include: a two million SF Black Creek Group industrial portfolio, the 1,622,000 SF BellWorks Hoffman Estates office campus, an 810,000 SF Goldman Sachs portfolio, another 4.3 million SF of industrial assets, and multiple new office assets.
