An integral piece of the Initiative is the *NAIOP Chicago Future Leaders University Scholarship Program* which **provides tuition assistance as well as other professional benefits** to qualifying students enrolled in a commercial real estate program at select institutions.

Scholarship Criteria*

- Enrolled as a **graduate student**, full-time or part-time (enrolled in a minimum of 4 classes within a year from application date); Minimum 3.0 GPA
- 35 and Under

**All applicants who meet the above criteria will receive complimentary attendance to a 2022 NAIOP Chicago program.*

Scholarship Expectations

- Attendance at a minimum of 1 NAIOP Chicago program throughout the 2022-23 school year
- Attendance at a minimum of 2 NAIOP Chicago Developing Leaders Events for Young Professionals
- Participation in the 2022 NAIOP Chicago Awards for Excellence Dinner (*November 2022*)
- Participation in the 2023 NAIOP Chicago Mentorship Program
(*Consists of quarterly meetings with a senior real estate mentor scheduled at mutually agreeable times/locations*)

Scholarship Winner Benefits (*Two scholarships awarded*)

- \$10,000 towards school tuition plus additional benefits listed below (value: \$2,500):
 - A one-year NAIOP Developing Leader Membership (*Membership for 35 and under*)
