- CenterPoint Properties, general contractor Morgan Harbour, Cornerstone Architects, and NAI Hiffman brokers collaborated on the construction of a new speculative industrial building at CenterPoint Intermodal Center. In September 2022, The Home Depot leased the facility long-term to support their nearby SDC/RDC operations. The building is 990,140 SF, is 40' clear and features 80 exterior (exp), 4 DID's, 413 trailer parking positions (exp), and 298 car parking spaces. The cross-docked building is just under 815,000 square feet with 450 trailers, 132 docks, 6,000 amps of power and 32' clear height throughout.
