- In 2021, Allstate made the decision to sell 3075 Sanders Road and surrounding land and engaged with existing partners, Colliers' Suzanne Serino and Bill Fausone, to market the site. The underutilized, 232-acre campus with more than 1.8 million square feet of office space was one of the largest redevelopment opportunities to be offered in the Chicago area in more than a decade. Colliers closed the sale to Dermody Properties in October of 2022. Dermody has five spec buildings under construction totaling 1.2 million square feet in Phase I and can build up to 1.8 million square feet in Phase II.

Multi-Tenant Industrial Portfolio Sale in O'Hare | 1700 Elmhurst Road / 2750 Greenleaf Ave, Elk Grove, IL

- Colliers' Jeff Devine, Steve Disse and Tyler Ziebel represented Stockbridge in the sale of a
  multi-tenant industrial portfolio located on approximately 47 acres adjacent to Chicago's
  O'Hare International Airport. Marketed in a highly volatile 2H 2022, the portfolio was sold in
  its entirety to Boston-based TA Realty. The subject portfolio consisted of twenty-one buildings
  totaling 757,557 square feet. At the time of sale, the buildings were 97% occupied by 107
  tenants ranging in size from 2,700 SF to 21,500 SF. The portfolio was marketed as an
  opportunity to control a dependable income stream or as a rare redevelopment opportunity in
  one of the tightest industrial markets in the U.S.
