- -The Silos at Sanders Farms Building One and the future buildings in The Silos at Sanders Farm development that are currently under construction bring much-needed warehouse and distribution spaces to northwest Indiana. CAGE designed not only the private site improvements, but the supportive infrastructure including water main extensions, sanitary sewer extensions, regional sanitary lift station and signalized intersection improvements. This development will create 500 jobs for the town of Merrillville and will make the city a viable competitive option for the Chicagoland marketplace.
- -1211 Tower Road in Schaumburg, Illinois brings a Class A industrial building to one of Chicago's top infill suburban submarkets. It is perfectly positioned near O'Hare airport and two major interstates to service a large population as demand for e-commerce continues to grow.
